**Overview of Student Funding Schemes (2023-24)**

**Purpose**

We commit to organizing and arranging a wide range of life-wide learning (LWL) activities to enhance students' learning effectiveness, which helps to broaden their learning experiences outside the classroom and enhance their sense of belonging to the community. Various types of career and counseling activities are organized to develop students' potential for the purpose of whole-person development. Students with financial needs can be partially funded to make sure that they enjoy equal opportunities to join the activities as the other students in the school. All S.1-S.6 students who have participated in extracurricular activities organized or recognized by school and meet one of the following criteria may apply for the subsidy. There are two subsidy schemes available for application as follows.

<b>Purpose</b>	To provide more assistance and opportunities to the disadvantaged students to improve their learning effectiveness, broaden their learning experiences outside the classroom and raise their understanding of the community and sense of belonging so as to facilitate students' whole-person and all round development.		
<b>Scope of activities</b>	subject-based learning activity (academically-oriented tutorial service)	Personal development (e.g. school-based Life-wide Learning activities, cultural and art activities, sports activities, leadership training, voluntary service, visits, etc.) and skills training	a) Life-wide learning activities, organised or recognised by schools, including school-based learning activities, extra-curricular activities and after-school activities with clear learning objectives b) diversified learning activities (including intellectual development, moral and civic education, community service, physical and aesthetic development, and career-related experiences) c) local or non-local competitions, exchange activities outside Hong Kong, fee-charging activities or training programmes and d) purchase basic and essential learning materials and equipment (e.g. musical instruments and sports equipment) for participating in life-wide learning activities.
Note: All fees and expenses related to examinations or tuition classes are not applicable.			
<b>Eligible Students</b>	1) Students receiving "Comprehensive Social Security Assistance" (CSSA) 2) Full grant under the School Textbook Assistance Scheme (STAS-Full) 3) Half grant under the School Textbook Assistance Scheme (STAS-Half) or 4) defined as "financially needy" by the school.		
<b>Amount of subsidy</b>	1) It will be adjusted with reference to the financial condition of the family. 2) It will be adjusted with reference to the cost of each activity and the number of participants. 3) The exact amount of funding for each activity will be announced later.
